Official Rules for the Concourse Hosting Blackbaud CRM community giveaways:

BBCRM Community Discord Launch Giveaway rules:

- (1) No purchase is necessary to enter the giveaway. Discord is a free service.
- (2) The giveaway begins 12/9/24 starting at 6am pacific standard time, ending 1/31/25 at 6pm pacific standard time.
